ठाणे, 14 नवंबर (भाषा)।

महाराष्ट्र भाजपा के अध्यक्ष रावसाहेब दानवे ने बुधवार को कहा कि उनकी पार्टी इस महीने के अंत में अयोध्या की यात्रा करने के शिवसेना प्रमुख उद्भव ठाकरे के निर्णय का स्वागत करती है।
